IF YOU HAVE ACCESS TO A FIREARM, PRACTICE REGULARLY TO IMPROVE YOUR SKILLS. FOCUS ON THE FOLLOWING AREAS:

- SHOOTING ACCURACY: SPEND TIME AT THE RANGE TO DEVELOP YOUR AIM AND CONTROL.
- LOADING AND UNLOADING: PRACTICE THESE SKILLS UNTIL THEY BECOME SECOND NATURE.
- SAFETY PROTOCOLS: ALWAYS ADHERE TO SAFETY PROTOCOLS WHEN HANDLING FIREARMS, REINFORCING GOOD HABITS.

4. TAKE PRACTICE EXAMS
