

SOCIAL STRATIFICATION AND INEQUALITY KERBO

SOCIAL STRATIFICATION AND INEQUALITY KERBO REFER TO THE SYSTEMATIC CATEGORIZATION OF INDIVIDUALS AND GROUPS WITHIN SOCIETY BASED ON VARIOUS SOCIO-ECONOMIC FACTORS. UNDERSTANDING SOCIAL STRATIFICATION

THE MECHANISMS OF INEQUALITY

SOCIAL STRATIFICATION DOES NOT OCCUR RANDOMLY; SEVERAL MECHANISMS CONTRIBUTE TO THE PERPETUATION OF INEQUALITY. UNDERSTANDING THESE MECHANISMS IS CRUCIAL FOR ADDRESSING AND MITIGATING THE EFFECTS OF SOCIAL STRATIFICATION.

1. ECONOMIC FACTORS

ECONOMIC FACTORS PLAY A SIGNIFICANT ROLE IN SOCIAL STRATIFICATION. WEALTH ACCUMULATION, ACCESS TO HIGH-PAYING JOBS, AND THE ABILITY TO INVEST IN EDUCATION CAN CREATE SIGNIFICANT DISPARITIES. SOME KEY POINTS INCLUDE:

- **SOCIALIZATION:** THE VALUES AND BELIEFS INSTILLED IN INDIVIDUALS FROM A YOUNG AGE CAN SHAPE THEIR ASPIRATIONS AND OPPORTUNITIES.
- **DISCRIMINATION:** SYSTEMIC RACISM, SEXISM, AND OTHER FORMS OF DISCRIMINATION CAN LIMIT ACCESS TO RESOURCES FOR MARGINALIZED GROUPS.
- **SOCIAL CAPITAL:** NETWORKS OF RELATIONSHIPS AND CONNECTIONS CAN PROVIDE INDIVIDUALS WITH OPPORTUNITIES THAT ARE UNAVAILABLE TO THOSE OUTSIDE THESE NETWORKS.

3. POLITICAL FACTORS

POLITICAL POWER CAN HEAVILY INFLUENCE SOCIAL STRATIFICATION. KEY ASPECTS INCLUDE:

- **POLICY DECISIONS:** LAWS AND REGULATIONS CAN EITHER PROMOTE EQUALITY (E.G., AFFIRMATIVE ACTION) OR ENTRENCH INEQUALITY (E.G., VOTER SUPPRESSION).
- **REPRESENTATION:** UNDERREPRESENTATION OF MARGINALIZED GROUPS IN POLITICAL OFFICES CAN LEAD TO POLICIES THAT FAIL TO ADDRESS THEIR NEEDS AND CONCERNS.

CONSEQUENCES OF SOCIAL STRATIFICATION AND INEQUALITY

THE CONSEQUENCES OF SOCIAL STRATIFICATION AND INEQUALITY ARE PROFOUND AND FAR-REACHING. THEY AFFECT NOT ONLY INDIVIDUALS BUT ALSO THE OVERALL HEALTH AND STABILITY OF SOCIETY.

1. SOCIAL MOBILITY
