BEYOND CRIMINAL PENALTIES, TEACHERS INVOLVED IN SUCH CASES FACE TERMINATION FROM THEIR POSITIONS, REVOCATION OF TEACHING CREDENTIALS, AND CIVIL LAWSUITS FILED BY THE MINOR'S FAMILY. SCHOOL DISTRICTS MAY ALSO FACE SCRUTINY IF INADEQUATE OVERSIGHT OR PREVENTION MEASURES ARE FOUND.

PSYCHOLOGICAL AND EMOTIONAL IMPACT

- SUPPORT SYSTEMS FOR STUDENTS TO REPORT ABUSE SAFELY
