PASSING THE TENNESSEE MPJE IS A MANDATORY STEP FOR LICENSURE BY THE TENNESSEE BOARD OF PHARMACY.

ELIGIBILITY AND REGISTRATION

REGISTRATION FOR THE EXAM IS COMPLETED THROUGH NABP, AND CANDIDATES MUST SELECT TENNESSEE AS THEIR DESIGNATED STATE FOR THE MPJE. IT IS IMPORTANT TO SCHEDULE THE EXAM WELL IN ADVANCE AND VERIFY ALL ELIGIBILITY CRITERIA TO AVOID DELAYS IN LICENSURE.

TENNESSEE STATE PHARMACY LAW
