ADDITIONALLY, TEXAS FEATURES MAJOR AIRPORTS INCLUDING DALLAS/FORT WORTH INTERNATIONAL AIRPORT AND GEORGE BUSH INTERCONTINENTAL AIRPORT IN HOUSTON, WHICH SUPPORT CARGO AND PASSENGER AIR TRAFFIC VITAL TO NORTH AMERICAN CONNECTIVITY.

ECONOMIC IMPACT OF TEXAS AS A CROSSROADS
