UNDERSTANDING TEXAS PROPERTY DIVISION LAWS

TEXAS FOLLOWS COMMUNITY PROPERTY LAWS, WHICH FUNDAMENTALLY INFLUENCE HOW ASSETS AND DEBTS ARE DIVIDED DURING A DIVORCE. COMMUNITY PROPERTY VS. SEPARATE PROPERTY
