OVERVIEW OF THE TEXAS ESTHETICIAN WRITTEN EXAM

THE TEXAS ESTHETICIAN WRITTEN EXAM IS A LICENSING EXAMINATION MANDATED BY THE TEXAS DEPARTMENT OF LICENSING AND REGULATION (TDLR) FOR ALL ASPIRING ESTHETICIANS IN TEXAS. THE EXAM IS DESIGNED TO EVALUATE CANDIDATES' KNOWLEDGE OF SKIN CARE PRINCIPLES, SAFETY PROTOCOLS, AND STATE LAWS GOVERNING ESTHETIC PRACTICES. PASSING THIS EXAM IS A MANDATORY STEP BEFORE OBTAINING AN ESTHETICIAN LICENSE, WHICH PERMITS PROFESSIONALS TO OFFER COSMETIC SKIN CARE SERVICES LEGALLY. THE EXAM ENSURES THAT ALL LICENSED ESTHETICIANS MEET A STANDARD LEVEL OF COMPETENCE, PROTECTING PUBLIC HEALTH AND SAFETY. PURPOSE OF THE EXAM

ADMINISTERING AUTHORITY

THE TEXAS DEPARTMENT OF LICENSING AND REGULATION (TDLR) ADMINISTERS THE TEXAS ESTHETICIAN WRITTEN EXAM. THE TDLR ESTABLISHES THE EXAM CONTENT, SCORING CRITERIA, AND LICENSING REGULATIONS. CANDIDATES MUST COMPLY WITH TDLR GUIDELINES THROUGHOUT THE APPLICATION AND EXAMINATION PROCESS.

ELIGIBILITY AND REQUIREMENTS

EXAM CONTENT AND STRUCTURE
