THIS ENDORSEMENT IS CRUCIAL FOR DRIVERS WHO HANDLE SUBSTANCES CLASSIFIED AS DANGEROUS UNDER FEDERAL AND STATE REGULATIONS. THE ENDORSEMENT ENSURES THAT DRIVERS POSSESS THE KNOWLEDGE AND SKILLS REQUIRED TO SAFELY TRANSPORT HAZARDOUS CARGO, MINIMIZING RISKS TO PUBLIC SAFETY AND THE ENVIRONMENT.
