- EXAMPLE: "WHAT IS THE LEGAL SIGNIFICANCE OF ACCURATE PATIENT RECORDS?"

QUESTION 1

ANSWER: B) DOCUMENT THE REFUSAL AND INFORM THE PHYSICIAN. NURSES MUST RESPECT PATIENT AUTONOMY WHILE ENSURING THAT APPROPRIATE DOCUMENTATION IS MAINTAINED.

QUESTION 3

WHICH OF THE FOLLOWING IS NOT A PATIENT RIGHT?

- A) RIGHT TO REFUSE TREATMENT
- B) RIGHT TO CONFIDENTIALITY
- C) RIGHT TO DEMAND SPECIFIC TREATMENTS
- D) RIGHT TO RECEIVE INFORMATION ABOUT THEIR CARE

ANSWER: C) RIGHT TO DEMAND SPECIFIC TREATMENTS. WHILE PATIENTS HAVE THE RIGHT TO BE INFORMED AND TO REFUSE TREATMENT, THEY DO NOT HAVE THE RIGHT TO DEMAND SPECIFIC TREATMENTS THAT MAY NOT BE CLINICALLY INDICATED.
