THE EXAM IS ADMINISTERED AT AUTHORIZED TESTING CENTERS ACROSS TEXAS. IT IS COMPUTER-BASED, PROVIDING IMMEDIATE RESULTS IN MOST CASES. CANDIDATES MUST BRING VALID IDENTIFICATION AND COMPLY WITH TESTING CENTER REGULATIONS.
