CERTIFIED INSPECTORS MUST PASS THE TEXAS STATE INSPECTION TEST TO LEGALLY PERFORM VEHICLE INSPECTIONS. THE PROGRAM AIMS TO IMPROVE ROAD SAFETY, REDUCE VEHICLE EMISSIONS, AND MAINTAIN ENVIRONMENTAL STANDARDS ACROSS THE STATE.

PURPOSE AND IMPORTANCE
