UNDERSTANDING THE AGE OF SUSTAINABLE DEVELOPMENT

THIS ERA IS DEFINED BY THE INTEGRATION OF ENVIRONMENTAL STEWARDSHIP, SOCIAL RESPONSIBILITY, AND ECONOMIC VIABILITY INTO DEVELOPMENT STRATEGIES. SUSTAINABLE DEVELOPMENT SEEKS TO CREATE RESILIENT COMMUNITIES THAT CAN THRIVE IN THE FACE OF ENVIRONMENTAL AND SOCIAL CHALLENGES. IT ACKNOWLEDGES THE INTERCONNECTEDNESS OF HUMAN AND NATURAL SYSTEMS, EMPHASIZING THAT LONG-TERM PROSPERITY DEPENDS ON THE HEALTH OF THE PLANET AND THE WELL-BEING OF ALL PEOPLE.

HISTORICAL CONTEXT

THE CONCEPT OF SUSTAINABLE DEVELOPMENT GAINED INTERNATIONAL PROMINENCE FOLLOWING THE 1987 BRUNDTLAND REPORT, WHICH DEFINED IT AS DEVELOPMENT THAT "MEETS THE NEEDS OF THE PRESENT WITHOUT COMPROMISING THE ABILITY OF FUTURE GENERATIONS TO MEET THEIR OWN NEEDS." THIS REPORT LAID THE FOUNDATION FOR GLOBAL ENVIRONMENTAL POLICIES AND PAVED THE WAY FOR THE 1992 EARTH SUMMIT IN RIO DE JANEIRO. SINCE THEN, SUSTAINABLE DEVELOPMENT HAS EVOLVED TO ENCOMPASS A BROADER RANGE OF ISSUES INCLUDING CLIMATE CHANGE, BIODIVERSITY LOSS, SOCIAL JUSTICE, AND ECONOMIC INEQUALITY. THE ADOPTION OF THE UNITED NATIONS SUSTAINABLE DEVELOPMENT GOALS (SDGs) IN 2015 FURTHER SOLIDIFIED THIS FRAMEWORK AS A UNIVERSAL BLUEPRINT FOR GLOBAL DEVELOPMENT EFFORTS.

CORE PRINCIPLES OF SUSTAINABLE DEVELOPMENT

ENVIRONMENTAL PROTECTION
