THE HOTEL'S LOCATION WAS STRATEGICALLY CHOSEN TO MAXIMIZE THE APPEAL OF THE NATURAL ENVIRONMENT AND TO OFFER GUESTS AN IMMERSIVE EXPERIENCE OF TRANQUILITY AND REJUVENATION.

CONSTRUCTION CHALLENGES AND INNOVATIONS
