 - MANAGING GROUP DYNAMICS
3. OBSERVATIONS: RESEARCHERS IMMERSE THEMSELVES IN THE ENVIRONMENT OF THEIR SUBJECTS TO GATHER DATA ON BEHAVIORS AND INTERACTIONS. THIS METHOD CAN BE:
 - PARTICIPANT OBSERVATION: THE RESEARCHER BECOMES PART OF THE GROUP BEING STUDIED.
 - NON-PARTICIPANT OBSERVATION: THE RESEARCHER OBSERVES FROM A DISTANCE.

DATA ANALYSIS IN QUALITATIVE RESEARCH

THE ANALYSIS OF QUALITATIVE DATA REQUIRES A DIFFERENT APPROACH THAN QUANTITATIVE ANALYSIS. AURINI EMPHASIZES THE IMPORTANCE OF SYSTEMATIC CODING AND THEMATIC ANALYSIS.

CODING TECHNIQUES
