

THE LAW JIM BUTCHER

THE LAW IN THE DRESDEN FILES

4. THE FOURTH LAW: THOU SHALT NOT TURN AN INNOCENT INTO A BEAST - TRANSFORMING AN INNOCENT INTO A CREATURE OR MONSTER IS SEEN AS A DISTORTION OF NATURE AND MORALITY.
5. THE FIFTH LAW: THOU SHALT NOT MAKE A WIZARD'S DUEL - ENGAGING IN A DUEL WITH ANOTHER WIZARD IS HEAVILY REGULATED, AS IT CAN LEAD TO SEVERE CONSEQUENCES.
6. THE SIXTH LAW: THOU SHALT NOT DENY THE FAITH - THIS LAW IS FOCUSED ON THE CONSEQUENCES OF BETRAYING ONE'S MAGICAL HERITAGE AND THE RESPONSIBILITIES THAT COME WITH IT.
7. THE SEVENTH LAW: THOU SHALT NOT USE MAGIC TO CONTROL OTHERS - THE USE OF MAGIC FOR DOMINATION OR OPPRESSION IS FORBIDDEN, EMPHASIZING THE IMPORTANCE OF AUTONOMY.

THE CONSEQUENCES OF BREAKING THE LAW

IN THE DRESDEN FILES, BREAKING THE LAW CAN LEAD TO DIRE CONSEQUENCES. THE ENFORCEMENT OF THESE LAWS IS TYPICALLY MANAGED BY THE WHITE COUNCIL, A GOVERNING BODY OF WIZARDS THAT OVERSEES THE MAGICAL COMMUNITY. WHEN SOMEONE BREAKS THE LAW, THEY MAY FACE:

CHARACTER DEVELOPMENT THROUGH THE LAW
