

# THE MINDS OF BILLY MILLIGAN DANIEL KEYES

  - ADALANA: A FEMALE PERSONALITY WHO HAD A SOFTER, NURTURING DEemeanor.

THIS MULTIPLICITY WAS NOT JUST A CLINICAL PHENOMENON; IT REFLECTED BILLY'S STRUGGLE TO COPE WITH HIS TRAUMATIC PAST.

### DANIEL KEYES: THE AUTHOR AND HIS PERSPECTIVE
