W.E.B. Du Bois

A LEADING AFRICAN AMERICAN INTELLECTUAL, W.E.B. DU BOIS CO-FOUNDED THE NAACP AND WORKED TIRELESSLY FOR CIVIL RIGHTS AND RACIAL EQUALITY. HIS ADVOCACY WAS CRUCIAL IN ADDRESSING THE RACIAL INJUSTICES OF THE TIME.

ROBERT LA FOLLETTE

AS A PROGRESSIVE POLITICIAN, ROBERT LA FOLLETTE SERVED AS GOVERNOR OF WISCONSIN AND LATER AS A U.S. SENATOR. HE CHAMPIONED VARIOUS REFORMS, INCLUDING LABOR RIGHTS, CAMPAIGN FINANCE REFORM, AND WOMEN'S SUFFRAGE.

MAJOR REFORMS OF THE PROGRESSIVE ERA

IMPACT OF THE PROGRESSIVE ERA
