TERM LENGTH AND LIMITS

MEMBERS OF THE HOUSE SERVE TWO-YEAR TERMS, WHILE SENATORS SERVE SIX-YEAR TERMS, WITH ELECTIONS STAGGERED SO THAT APPROXIMATELY ONE-THIRD OF THE SENATE IS UP FOR ELECTION EVERY TWO YEARS. SENATE LEADERSHIP

IN THE SENATE, THE VICE PRESIDENT OF THE UNITED STATES SERVES AS THE PRESIDENT OF THE SENATE BUT ONLY VOTES TO BREAK TIES. THE SENATE MAJORITY LEADER HOLDS SIGNIFICANT INFLUENCE BY SCHEDULING LEGISLATIVE BUSINESS AND GUIDING PARTY STRATEGY. MINORITY LEADERS AND WHIPS PERFORM FUNCTIONS SIMILAR TO THEIR HOUSE COUNTERPARTS, MAINTAINING PARTY COHESION AND COMMUNICATION.

ROLE OF PARTY CAUCUSES AND CONFERENCES

BOTH CHAMBERS HAVE PARTY CAUCUSES OR CONFERENCES WHERE MEMBERS MEET TO DISCUSS POLICIES, SELECT LEADERS, AND DEVELOP LEGISLATIVE PRIORITIES. THESE GATHERINGS ARE CRUCIAL FOR MAINTAINING PARTY UNITY AND FORMULATING COLLECTIVE STRATEGIES.

COMMITTEES AND THEIR FUNCTIONS

COMMITTEE MEMBERSHIP AND LEADERSHIP

MEMBERS ARE ASSIGNED TO COMMITTEES BASED ON PARTY REPRESENTATION AND INDIVIDUAL EXPERTISE. COMMITTEE CHAIRS, USUALLY FROM THE MAJORITY PARTY, WIELD SIGNIFICANT POWER IN SETTING AGENDAS AND INFLUENCING LEGISLATIVE OUTCOMES. RANKING MEMBERS REPRESENT THE MINORITY PARTY'S LEADERSHIP WITHIN COMMITTEES.

COMMITTEE FUNCTIONS

PRESIDENTIAL ACTION

ONCE BOTH CHAMBERS PASS A BILL, IT IS SENT TO THE PRESIDENT, WHO MAY SIGN IT INTO LAW, VETO IT, OR TAKE NO ACTION. CONGRESS CAN OVERRIDE A VETO WITH A TWO-THIRDS MAJORITY IN BOTH CHAMBERS, ENSURING A SYSTEM OF CHECKS AND BALANCES.

ADDITIONAL PROCEDURES
