BACKGROUND AND PURPOSE OF THE TURNAWAY STUDY

THE TURNAWAY STUDY WAS DESIGNED TO PROVIDE EVIDENCE-BASED CONCLUSIONS ABOUT THE HEALTH, SOCIOECONOMIC, AND EMOTIONAL CONSEQUENCES RELATED TO ABORTION DECISIONS.

HISTORICAL CONTEXT
