HISTORICAL CONTEXT AND MAJOR EVENTS

RELIGIOUS TURMOIL

- THE MANORIAL SYSTEM WEAKENED AS WAGE LABOR INCREASED.
- GUILDS IN TOWNS REGULATED TRADES AND CRAFTS, SHAPING ECONOMIC LIFE.

POLITICAL CHANGES AND THE DECLINE OF FEUDALISM

THE WANING OF THE MIDDLE AGES ALSO CORRESPONDED WITH SIGNIFICANT POLITICAL SHIFTS THAT TRANSFORMED MEDIEVAL GOVERNANCE AND CONTRIBUTED TO THE RISE OF CENTRALIZED STATES.

RISE OF MONARCHIES
