THIS REPUBLIC OF SUFFERING: DEATH AND THE AMERICAN CIVIL WAR

UNDERSTANDING DEATH AND ITS IMPACT

- MOURNING LITERATURE: A SURGE IN LITERATURE ABOUT DEATH, LOSS, AND MOURNING HELPED PEOPLE ARTICULATE THEIR GRIEF.

DEATH AS A PUBLIC CONCERN

THE COLLECTIVE EXPERIENCE OF LOSS PROMPTED A SHIFT IN HOW DEATH WAS PERCEIVED AND DEALT WITH IN AMERICAN

SOCIETY. KEY DEVELOPMENTS INCLUDED:

- ESTABLISHMENT OF NATIONAL CEMETERIES: THE GOVERNMENT BEGAN TO CREATE NATIONAL CEMETERIES TO HONOR FALLEN SOLDIERS. THIS WAS A SIGNIFICANT STEP IN RECOGNIZING THE SACRIFICES MADE DURING THE WAR.
- BURIAL SOCIETIES: COMMUNITIES FORMED BURIAL SOCIETIES TO ENSURE THAT MEMBERS COULD AFFORD PROPER FUNERALS AND BURIALS.
- MEMORIALIZATION: THE WAR SPURRED THE CREATION OF MONUMENTS AND MEMORIALS, WHICH BECAME CENTRAL TO COMMUNITY IDENTITIES AND COLLECTIVE MEMORY.

THE ROLE OF WOMEN IN MOURNING AND MEMORIALIZATION

- GRIEF IN LITERATURE AND ART: WOMEN WRITERS AND ARTISTS CONTRIBUTED TO THE CULTURAL LANDSCAPE BY EXPRESSING GRIEF THROUGH POETRY, NOVELS, AND VISUAL ART.

THE PSYCHOLOGICAL TOLL OF WAR

THE PSYCHOLOGICAL IMPACT OF THE CIVIL WAR AND ITS ASSOCIATED DEATHS LED TO THE EMERGENCE OF WHAT WE NOW RECOGNIZE AS POST-TRAUMATIC STRESS DISORDER (PTSD). SOLDIERS WHO SURVIVED THE BATTLEFIELD OFTEN RETURNED HOME PROFOUNDLY CHANGED, GRAPPLING WITH THEIR EXPERIENCES OF VIOLENCE AND DEATH.

SIGNS OF PSYCHOLOGICAL DISTRESS

- SOLDIER'S HEART: THIS TERM WAS USED DURING THE CIVIL WAR TO DESCRIBE THE PSYCHOLOGICAL TRAUMA EXPERIENCED BY SOLDIERS, MANIFESTING AS ANXIETY, DEPRESSION, AND PHYSICAL AILMENTS.
- CIVILIAN IMPACT: FAMILIES OF SOLDIERS ALSO FACED PSYCHOLOGICAL CHALLENGES, AS THEY DEALT WITH THE LOSS OF LOVED ONES AND THE TRAUMA OF SEPARATION.
