

# TITLE AGENT EXAM FLORIDA

2. PAY THE EXAM FEE: THERE IS A FEE ASSOCIATED WITH TAKING THE TITLE AGENT EXAM. ENSURE YOU CHECK THE CURRENT FEE STRUCTURE AS IT MAY CHANGE.
3. GATHER REQUIRED MATERIALS: ON THE DAY OF THE EXAM, BRING VALID IDENTIFICATION (SUCH AS A GOVERNMENT-ISSUED PHOTO ID) AND ANY OTHER REQUIRED DOCUMENTS.

ONCE LICENSED, TITLE AGENTS MUST COMPLETE CONTINUING EDUCATION COURSES TO MAINTAIN THEIR LICENSE. FLORIDA REQUIRES TITLE AGENTS TO COMPLETE A SPECIFIC NUMBER OF HOURS OF EDUCATION EVERY RENEWAL CYCLE.
