## DISTINCTION BETWEEN TONE AND STYLE

## TYPES OF TONE IN ACADEMIC WRITING

SPECIFIC POSITION OR HYPOTHESIS. THIS TONE USES REASONED ARGUMENTS, SUPPORTED BY EVIDENCE, TO CONVINCE READERS OF A PARTICULAR VIEWPOINT WITHOUT RESORTING TO EMOTIONAL MANIPULATION.

## STRATEGIES FOR MAINTAINING AN APPROPRIATE TONE

MAINTAINING THE CORRECT TONE THROUGHOUT AN ACADEMIC PAPER REQUIRES CONSCIOUS EFFORT AND ATTENTION TO DETAIL. THE FOLLOWING STRATEGIES HELP WRITERS ACHIEVE AND SUSTAIN AN APPROPRIATE TONE IN THEIR WORK.

4. **MAINTAIN OBJECTIVITY:** FOCUS ON EVIDENCE AND LOGIC, STEERING CLEAR OF PERSONAL BIAS OR EMOTIONAL LANGUAGE.
5. **ADOPT A CONSISTENT VOICE:** ENSURE THAT THE TONE REMAINS UNIFORM THROUGHOUT THE DOCUMENT TO AVOID CONFUSING THE READER.
6. **REVISE AND EDIT:** REVIEW THE TEXT MULTIPLE TIMES TO IDENTIFY AND CORRECT TONE INCONSISTENCIES OR INAPPROPRIATE LANGUAGE.

## USING PASSIVE VS. ACTIVE VOICE

WHILE ACTIVE VOICE IS GENERALLY PREFERRED FOR CLARITY, PASSIVE VOICE CAN BE USEFUL IN ACADEMIC WRITING TO MAINTAIN AN OBJECTIVE TONE BY FOCUSING ON THE ACTION RATHER THAN THE ACTOR. WRITERS SHOULD BALANCE BOTH VOICES APPROPRIATELY TO ENHANCE READABILITY WITHOUT COMPROMISING FORMALITY.

## COMMON MISTAKES AND HOW TO AVOID THEM

## INCONSISTENT TONE

SWITCHING BETWEEN FORMAL AND INFORMAL TONES OR MIXING SUBJECTIVE AND OBJECTIVE LANGUAGE CONFUSES READERS. MAINTAINING A CONSISTENT TONE INVOLVES CAREFUL PLANNING AND THOROUGH EDITING.

## OVERCOMPLICATION AND JARGON

WHILE PRECISION IS IMPORTANT, EXCESSIVELY COMPLEX SENTENCES OR UNNECESSARY JARGON CAN OBSCURE MEANING. AIM FOR CLARITY AND SIMPLICITY WITHOUT SACRIFICING ACCURACY.

## NEGLECTING AUDIENCE EXPECTATIONS
