UNDERSTANDING TRAUMA INFORMED CARE

THIS APPROACH RECOGNIZES THAT TRAUMA CAN AFFECT INDIVIDUALS IN MANY WAYS, INCLUDING EMOTIONAL, PHYSICAL, AND PSYCHOLOGICAL DIMENSIONS, AND THAT THESE EFFECTS INFLUENCE BEHAVIOR AND RESPONSES.

DEFINITION AND PRINCIPLES

TRAUMA INFORMED CARE ENCOMPASSES SEVERAL CORE PRINCIPLES DESIGNED TO GUIDE SERVICE DELIVERY. THESE INCLUDE SAFETY, TRUSTWORTHINESS, PEER SUPPORT, COLLABORATION, EMPOWERMENT, AND CULTURAL SENSITIVITY.
