UNDERSTANDING TAXABLE INCOME FOR TRAVEL NURSES

TRAVEL NURSES OFTEN RECEIVE VARIOUS FORMS OF COMPENSATION, WHICH CAN COMPLICATE DETERMINING TAXABLE INCOME. UNLIKE TRADITIONAL NURSES, TRAVEL NURSES TYPICALLY EARN WAGES FROM MULTIPLE ASSIGNMENTS ACROSS DIFFERENT STATES, AND THEIR PAY STRUCTURE MAY INCLUDE HOURLY WAGES, STIPENDS, AND ALLOWANCES. IT IS CRITICAL TO IDENTIFY WHICH COMPONENTS OF COMPENSATION ARE SUBJECT TO FEDERAL AND STATE INCOME TAX.

WAGES AND BONUSES

HOURLY WAGES AND BONUSES RECEIVED BY TRAVEL NURSES ARE GENERALLY CONSIDERED TAXABLE INCOME. THESE AMOUNTS MUST BE REPORTED ON TAX RETURNS AS PART OF ORDINARY INCOME, SUBJECT TO FEDERAL AND APPLICABLE STATE TAXES. EMPLOYERS PROVIDE FORM W-2 DETAILING THESE EARNINGS AT YEAR-END.

STIPENDS AND ALLOWANCES

MANY TRAVEL NURSES RECEIVE STIPENDS OR ALLOWANCES FOR HOUSING, MEALS, AND INCIDENTALS. WHETHER THESE ALLOWANCES ARE TAXABLE DEPENDS ON HOW THEY ARE STRUCTURED AND DOCUMENTED. IF THE ALLOWANCE IS CONSIDERED A REIMBURSEMENT FOR ACTUAL EXPENSES INCURRED AND SUBSTANTIATED WITH RECEIPTS, IT MAY BE NON-TAXABLE. HOWEVER, IF PAID AS A FLAT AMOUNT WITHOUT EXPENSE TRACKING, IT IS USUALLY TAXABLE INCOME.

TAXABLE VS. NON-TAXABLE INCOME

UNDERSTANDING THE DISTINCTION BETWEEN TAXABLE AND NON-TAXABLE INCOME IS ESSENTIAL TO AVOID OVERPAYING TAXES. GENERALLY, REIMBURSEMENTS FOR QUALIFIED BUSINESS EXPENSES UNDER AN ACCOUNTABLE PLAN ARE EXCLUDED FROM TAXABLE INCOME. CONVERSELY, NON-ACCOUNTABLE PLAN PAYMENTS ARE REPORTED AS WAGES. TRAVEL NURSES SHOULD CONSULT THEIR CONTRACTS AND PAYROLL DETAILS TO DETERMINE THE NATURE OF THEIR ALLOWANCES.

PER DIEM AND HOUSING ALLOWANCES

PER DIEM AND HOUSING ALLOWANCES ARE COMMON COMPONENTS OF TRAVEL NURSE COMPENSATION PACKAGES. THESE PAYMENTS AIM TO COVER DAILY LIVING AND LODGING COSTS WHILE ON ASSIGNMENT AND HAVE SPECIFIC TAX IMPLICATIONS UNDER IRS RULES.

IRS PER DIEM RULES

THE IRS ALLOWS EMPLOYERS TO PAY PER DIEM RATES TO COVER MEALS AND INCIDENTAL EXPENSES WITHOUT INCLUDING THESE AMOUNTS IN TAXABLE INCOME, PROVIDED THE PAYMENTS DO NOT EXCEED FEDERAL PER DIEM LIMITS. TRAVEL NURSES RECEIVING PER DIEM PAYMENTS WITHIN THESE LIMITS GENERALLY DO NOT NEED TO REPORT THEM AS INCOME.

HOUSING ALLOWANCES AND TAXABILITY

HOUSING ALLOWANCES ARE OFTEN PROVIDED EITHER AS A DIRECT REIMBURSEMENT OR A FLAT STIPEND. WHEN THE HOUSING ALLOWANCE REIMBURSES ACTUAL LODGING EXPENSES AND IS SUPPORTED BY RECEIPTS, IT IS GENERALLY NON-TAXABLE. IF IT'S A FLAT AMOUNT NOT TIED TO ACTUAL EXPENSES, IT IS USUALLY TAXABLE. TRAVEL NURSES SHOULD MAINTAIN DETAILED RECORDS OF HOUSING EXPENSES TO SUBSTANTIATE NON-TAXABLE REIMBURSEMENTS.

RECORD-KEEPING FOR ALLOWANCES

PROPER DOCUMENTATION IS CRUCIAL FOR TAX PURPOSES. TRAVEL NURSES SHOULD KEEP COPIES OF LEASE AGREEMENTS, RECEIPTS, AND PAYMENT RECORDS FOR HOUSING AND PER DIEM EXPENSES. DETAILED RECORDS HELP ENSURE ALLOWANCES ARE TREATED CORRECTLY FOR TAX REPORTING AND REDUCE THE RISK OF IRS SCRUTINY.

STATE TAX CONSIDERATIONS FOR TRAVEL NURSES

WORKING IN MULTIPLE STATES PRESENTS COMPLEX STATE TAX CHALLENGES FOR TRAVEL NURSES. EACH STATE HAS ITS OWN TAX LAWS, RESIDENCY RULES, AND FILING REQUIREMENTS, WHICH CAN IMPACT HOW INCOME IS TAXED AND REPORTED.

STATE RESIDENCY RULES

DETERMINING RESIDENCY STATUS IS FUNDAMENTAL TO UNDERSTANDING STATE TAX OBLIGATIONS. FILING MULTIPLE STATE TAX RETURNS

TRAVEL NURSES OFTEN EARN INCOME IN SEVERAL STATES, NECESSITATING FILING TAX RETURNS IN EACH STATE WHERE INCOME WAS EARNED. NON-RESIDENT RETURNS TYPICALLY REPORT ONLY INCOME EARNED WITHIN THAT STATE, WHILE RESIDENT STATES TAX WORLDWIDE INCOME WITH CREDITS FOR TAXES PAID TO OTHER STATES TO AVOID DOUBLE TAXATION.

RECIPROCITY AGREEMENTS

SOME STATES HAVE RECIPROCITY AGREEMENTS THAT SIMPLIFY TAX FILING FOR WORKERS CROSSING STATE LINES. TRAVEL NURSES SHOULD VERIFY IF ANY STATES WHERE THEY WORK HAVE SUCH AGREEMENTS, AS THIS CAN REDUCE THE NEED TO FILE MULTIPLE STATE RETURNS OR WITHHOLDINGS.

COMMON TAX DEDUCTIONS AND CREDITS

TRAVEL NURSES CAN CAPITALIZE ON VARIOUS TAX DEDUCTIONS AND CREDITS TO LOWER THEIR TAXABLE INCOME AND REDUCE THEIR TAX LIABILITY. KNOWING WHICH EXPENSES QUALIFY IS ESSENTIAL FOR ACCURATE TAX FILING.

DEDUCTIBLE TRAVEL EXPENSES

EXPENSES DIRECTLY RELATED TO WORK ASSIGNMENTS, SUCH AS MILEAGE, AIRFARE, AND RENTAL CARS, MAY BE DEDUCTIBLE IF NOT REIMBURSED BY EMPLOYERS. KEEPING DETAILED RECORDS OF TRAVEL COSTS IS NECESSARY TO CLAIM THESE DEDUCTIONS.

LICENSING AND CERTIFICATION FEES

FEES PAID FOR MAINTAINING NURSING LICENSES, CERTIFICATIONS, AND CONTINUING EDUCATION REQUIRED FOR ASSIGNMENTS ARE GENERALLY DEDUCTIBLE AS WORK-RELATED EXPENSES. THESE COSTS CAN ADD UP AND PROVIDE SUBSTANTIAL TAX SAVINGS.

HEALTH INSURANCE PREMIUMS

SELF-EMPLOYED TRAVEL NURSES OR THOSE WHO PAY FOR THEIR OWN HEALTH INSURANCE MAY BE ELIGIBLE TO DEDUCT PREMIUMS, REDUCING TAXABLE INCOME. THIS DEDUCTION IS ESPECIALLY RELEVANT FOR TRAVEL NURSES WHO WORK AS INDEPENDENT CONTRACTORS.

OTHER POTENTIAL DEDUCTIONS

- UNIFORMS AND WORK-RELATED CLOTHING NOT SUITABLE FOR EVERYDAY WEAR
- PROFESSIONAL ASSOCIATION DUES
- HOME OFFICE EXPENSES IF APPLICABLE

FILING TIPS AND IRS UPDATES FOR 2021
