- SIMPLE SUBJECT: A SINGLE NOUN OR PRONOUN.
- COMPOUND SUBJECT: TWO OR MORE NOUNS/PRONOUNS JOINED BY CONJUNCTIONS.
- COMPLETE SUBJECT: THE SIMPLE SUBJECT PLUS MODIFIERS.

EXPLORING PREDICATES AND THEIR TYPES

THE PREDICATE OF A SENTENCE TELLS WHAT THE SUBJECT DOES OR IS. IT IS THE PART OF THE SENTENCE THAT CONTAINS THE VERB AND PROVIDES INFORMATION ABOUT THE SUBJECT'S ACTION OR STATE OF BEING.
