2. GROWTH IN POPULARITY:

- BY THE EARLY 2000S, TEXT MESSAGING BEGAN TO TAKE OFF, PARTICULARLY AMONG YOUNGER USERS. IT WAS SEEN AS A DISCREET WAY TO COMMUNICATE WITHOUT THE NEED FOR VOICE CALLS.

RETENTION POLICIES AND PRIVACY
