- EDUCATING PATIENTS ABOUT THEIR MEDICATIONS AND POTENTIAL SIDE EFFECTS
- ADVOCATING FOR CHANGES IN MEDICATION REGIMENS WHEN NECESSARY

PREPARATION FOR LICENSURE EXAMS

THE VATI PHARMACOLOGY ASSESSMENT IS AN ESSENTIAL PREPARATORY TOOL FOR THE NCLEX-RN EXAM.  - THERAPEUTIC EFFECTS
 - SIDE EFFECTS
3. MEDICATION ADMINISTRATION: THIS INCLUDES:
 - ROUTES OF ADMINISTRATION
 - DOSAGE CALCULATIONS
 - SAFE HANDLING AND STORAGE OF MEDICATIONS
4. PATIENT EDUCATION: AN ESSENTIAL ASPECT OF NURSING, THIS AREA ASSESSES:
 - COMMUNICATION OF MEDICATION INFORMATION TO PATIENTS
 - STRATEGIES FOR ENHANCING PATIENT UNDERSTANDING AND ADHERENCE

SCORING AND INTERPRETATION

SCORES ON THE VATI PHARMACOLOGY ASSESSMENT ARE CALCULATED BASED ON THE NUMBER OF CORRECT ANSWERS. THE RESULTS ARE TYPICALLY PRESENTED IN THE FOLLOWING FORMAT:
