- ANSWER: THE MINIMUM WIDTH IS TYPICALLY 10-12 FEET, DEPENDING ON THE TYPE OF ROAD AND TRAFFIC CONDITIONS.

4. WHICH OF THE FOLLOWING IS NOT A REQUIRED PIECE OF PPE FOR WORKERS IN A WORK ZONE?

BEST PRACTICES FOR WORK ZONE TRAFFIC CONTROL

TO EFFECTIVELY MANAGE WORK ZONES, CONSIDER THE FOLLOWING BEST PRACTICES:

- REGULAR TRAINING: ENSURE ALL WORKERS ARE TRAINED ON THE LATEST SAFETY PROTOCOLS AND TRAFFIC CONTROL MEASURES.
- EFFECTIVE COMMUNICATION: MAINTAIN CLEAR COMMUNICATION AMONG ALL PERSONNEL IN THE WORK ZONE TO ENSURE EVERYONE IS AWARE OF THEIR RESPONSIBILITIES.
- SIGNAGE MAINTENANCE: REGULARLY CHECK THAT ALL SIGNS AND DEVICES ARE IN GOOD CONDITION AND PROPERLY POSITIONED.
- PUBLIC AWARENESS: USE ADVANCE NOTICE SIGNS AND PUBLIC INFORMATION CAMPAIGNS TO INFORM DRIVERS OF UPCOMING WORK ZONES.
