PURPOSE OF A PROBATION ASSESSMENT

THESE TOOLS HELP MEASURE FACTORS SUCH AS THE LIKELIHOOD OF REOFFENDING, TREATMENT REQUIREMENTS, AND COMPLIANCE CAPABILITIES. THE DATA COLLECTED INFORMS THE DEVELOPMENT OF A SUPERVISION PLAN TAILORED TO THE PROBATIONER'S UNIQUE SITUATION.

KEY COMPONENTS EVALUATED DURING ASSESSMENT
