DISTRIBUTION OF ILLEGAL CONTENT

COMMUNICATION DEVICES ARE ALSO EXPLOITED FOR DISTRIBUTING ILLEGAL MATERIALS SUCH AS CHILD PORNOGRAPHY, PIRATED CONTENT, OR OTHER CONTRABAND. THE USE OF COMMUNICATION FACILITIES IN THIS CONTEXT IS HEAVILY PENALIZED UNDER FEDERAL AND STATE LAWS.

LEGAL CONSEQUENCES AND PENALTIES
