INFLECTION AND DERIVATION

INFLECTIONAL MORPHOLOGY CHANGES A WORD'S TENSE, NUMBER, OR CASE WITHOUT ALTERING ITS CORE MEANING, WHILE DERIVATIONAL MORPHOLOGY CREATES NEW WORDS BY ADDING AFFIXES THAT CHANGE MEANING OR WORD CLASS.

COMPOUND WORDS

COMPOUNDING IS ANOTHER MORPHOLOGICAL PROCESS WHERE TWO OR MORE WORDS COMBINE TO FORM A NEW WORD WITH A DISTINCT MEANING, ILLUSTRATING THE DYNAMIC NATURE OF LANGUAGE STRUCTURE.

SYNTAX: SENTENCE CONSTRUCTION AND GRAMMAR

SYNTAX IS THE STUDY OF HOW WORDS COMBINE TO FORM PHRASES AND SENTENCES ACCORDING TO GRAMMATICAL RULES. IT IS A CRITICAL COMPONENT OF LANGUAGE STRUCTURE THAT GOVERNS SENTENCE FORMATION AND WORD ORDER.

AMBIGUITY AND POLYSEMY
